AGREEMENT REGARDING CODE OF CONDUCT:

Due to the unique composition of the Bassing Kids Camps, i.e. the children attending these camps on an individual basis and not as part of an organized group, we have found it necessary to install the following rules, which will be applied very strictly. This will try to ensure an atmosphere of healthy discipline where every child will be respected and will have the opportunity to live up to his or her full potential. This will also ensure the safe running of all activities.

THE FOLLOWING RULES APPLY:

- 1. No alcoholic refreshments, cigarettes, drugs, pornographic material, weapons, dangerous sharp objects or any such dangerous objects are allowed on these premises or on the person of campers. If any such items are found on the person or amongst the belongings of a camper, the camper's parents will be contacted immediately in order to come and fetch their child at our earest police station.
- 2. No sexual activities will be allowed between and amongst campers. Such behaviour will result in notifying both the campers' parents in order to come and fetch their children at our earest police station.
- Theft of another campers belongings will not be tolerated. Therefore, all cellphones and pocket money will be collected for safe keeping at the beginning of the camp until the end of the camp.
- 4. No boys allowed in girls' rooms and bathrooms and no girls allowed in boys' rooms and bathrooms.
- 5. Campers will at all times, give heed to all instructions, i.e. any rules or arrangements given to them by the owner or the facilita tors regarding the safe and organized running of activities.
- 6. No bad or disrespectful behaviour towards the camp organizers, any employees of SA BASS or any campers, will be tolerated. Campers will respect SA BASS staff and other campers at all times.
- 7. No swearing or bad language towards SA BASS staff or other campers will be tolerated.
- 8. Campers will not discriminate against other campers regarding culture, background, social standing, age, physical abilities, etc or pass any such negative, demoralizing and intimidating comments toward other campers.
- Campers are not allowed to move around outside their chalets after lights out in the evenings. We do have wild animals roaming in and around the camp at night. SA BASS cannot be held liable for any such injuries.
- 10. All SA BASS equipment and furniture will be handled with the utmost respect. Any breakages to SA BASS equipment and furniture will be for the camper's account. Smearing of shaving cream or toothpaste will not be allowed in the chalets and buildings.
- SA BASS requests that campers please behave themselves in an orderly and peaceful manner at mealtimes. No food fights will be tolerated.

Consequences for not adhering to rules nr. 1 - 3 - Parents will be contacted immediately in order to come and fetch camper at our earest police station. Full camp fees will be forfeited. Entrance to future SA BASS camps can be denied, depending on the severity of the offense. Consequences for not adhering to rules nr. 4 - 11 - Camper will receive 2 warnings. After the 3rd offense, his/her parents will be contacted in order to come and fetch camper at our earest police station. Full camp fees will be forfeited. Entrance to future SA BASS camps can be denied, depending on the severity of the offense.
